11.1 CONSTRUCTION OF NEW DWELLINGS

In-depth discussion regarding the construction of new dwellings in Barunga noting the following points:

- Department of Local Government, Housing and Community Development (DLGHCD) acknowledge that there was a communication breakdown between the department and community in regards to the new dwellings.
- The Barunga Local Authority and Housing Reference Group (HRG) request that consultation happen prior to any construction of dwellings, DLGHDC agrees to communicate more with the Local Authority, Housing Reference Group and Barunga Community.
- DLGHCD ensure all materials used are subject to rigorous testing and due diligence as well as being cyclone rated, repairable, durable and encourage local employment opportunities.
- The Local Authority and HRG request to have input on floor plans and designs. DLGHCD agrees, as long as the designs are within reason and budget constraints.
- DLGHDC disclosed information on the tender process and factors taken into consideration such as price, previous experience, local employment opportunities and buy local initiatives and time factors. They stated all tender applicants are subject to due diligence.
- Concerns raised over Contractors, with DLGHDC to look further into raised issues.
- Concerns raised over plaster sheeting in Norforce Park, and materials not being disposed of correctly.
- Discussion about fencing both individual existing fencing and new fencing, with a proposed height being 1.8m, and fencing materials were discussed.
- Concerns were raised regarding storm water drainage.
